PLEASE NOTE

Passport holders are responsible for obtaining the required documentation applicable for entry. Passports must be valid for at least six (6) months after completion of your journey and should also have sufficient blank pages for visas and Immigration stamps. **We highly recommend applying for visas at least 2 months prior to arrival.**

| KENYA | <p>Travellers are required to obtain an electronic travel authorization (eTA) prior to arrival. | MOZAMBIQUE | <p>Travellers from the following countries can obtain a visa waiver at all borders at a cost of \$10. Belgium, Canada, China, Denmark, Finland, France, Germany, Japan, Netherlands, Portugal, Russia, Saudi Arabia, Singapore, Spain, Sweden, Switzerland, Ukraine, UAE, United Kingdom, United States of America. Please note: in order to leave the country again they must retain their receipt All other nationalities require a visa on arrival at port of entry. Travellers will need a copy of their hotel reservation and on-ward flight tickets to obtain a visa on arrival.</p> |
| NAMIBIA | <p>Travellers may be required to obtain a visa prior to arrival depending on nationality. | RWANDA | <p>Travellers are required to obtain a visa. | SEYCHELLES | <p>Seychelles is a visa-free country, which means that there are no visa requirements. Travellers are required to complete Immigration procedures when travelling to and from Seychelles. | SOUTH AFRICA | <p>Travellers may be required to obtain a visa prior to arrival depending on nationality. | UGANDA | <p>Travellers are required to obtain a visa prior to arrival. | ZAMBIA | <p>Travellers may be required to obtain a visa prior to arrival or on arrival depending on nationality.</p> <ul style="list-style-type: none"> Nationalities that require a visa: https://www.zambiaimmigration.gov.zm/for-visitors/ Apply for a visa: https://eservices.zambiaimmigration.gov.zm/#/home KAZA UNIVISA – Allows multiple entries into Zambia, Zimbabwe and day trips to Botswana and is valid for 30 days.
